### **Associate Membership Criteria**

The NFDC have incorporated the category of Associate Member into the Federation, to enable companies whose activities bring them into close working association with the Demolition Industry, such as Plant Manufacturers, Suppliers, Insurance Service Providers, Waste Disposal Services and Scrap Metal Processors.

The Federation believes that these companies contribute knowledge and resources that enhance the demolition expertise as well as the technical and mechanical proficiency of the Corporate Membership. #### **Criteria**

1. Associate Members maybe admitted on the sole discretion of the Council upon such terms and conditions as the Council may determine from time to time.
2. Every applicant for Associate Membership must not in any form; undertake demolition work and must sign a declaration to this effect.
3. Applicants must satisfy the Federation with appropriate, valid reasons for Associate Membership.
4. Once accepted as a Member, applicants must agree to abide by the Constitution and Rules of the Federation, as far as these are applicable to an Associate Member.
5. Every applicant upon becoming a Member of the Federation; shall immediately pay an Annual Subscription.
